WHAT IS EWRB?

O. Reg. 20/17

- ✦ In February 2017, the Ontario government introduced the Reporting of Energy Consumption and Water Use Regulation 20/17. This new regulation requires owners of commercial, multi-unit residential, institutional or industrial buildings over 50,000 square feet in size to report their property's water and energy usage on an annual basis.

EWRB DEADLINES

Reporting

- ✦ Building owners are required to report their data to the Ministry of Energy by the beginning of July each year.

Implementation Phases

Commercial and industrial buildings 250,000 ft ² and larger	July 1, 2018 deadline (for 2017 calendar year)
Multi-unit residential, commercial & industrial buildings 100,000 ft ² and larger	July 1, 2019 deadline (for 2018 calendar year)
Multi-unit residential, commercial & industrial buildings 50,000 ft ² and larger	July 1, 2023 deadline (for 2019 calendar year)
